### **Public Safety Committee Members & Related Staff**

The meeting began at 6:05 and ended at 7:14. Councilmembers Chance La Fleur, Kimberly Lauk, and Kyle Jacobson were present as well as Police Chief Bob Huebler and Police Department Secretary Sarah McCormick.

## **Agenda Items**

### **Old Business**

- **School Resource Officer (SRO)** – Officer Reeves began on January 2, 2019.

### **New Business**

- **Hiring and Promotions – Information Only** – Dispatcher Mary Qualls hired on January 7, 2019 and is undergoing training. Civil Service appeal set for Feb 6, 2019. New assistant Department Chaplain Jessica Zielinski. Probationary Offer sent to Simon Ipema for final Corrections Officer opening on January 22, 2019.
- **PD Budget 2019** – Chief Huebler gave update on squad room update. City is still in the bidding process for flooring. There is no date yet set for jail radio interface install.
- **Review Ord 2651 to Amend EMC 2.72.020 Civil Service Commission** – Chief Huebler presented ordinance to amend Civil Service Rules in the event a Commissioner has a conflict of interest, they may recuse themselves and a temporary Commissioner will be appointed for the duration of the conflict of interest. Committee approved ordinance with a 3-0 approval vote.
- **Review 4-bed Jail contract w/Bonney Lake PD** – Chief Huebler updated the Committee on the contract, which is scheduled to begin February 1, 2019.
- **Information on electronic signage (speed and warning)** – Enumclaw Police Department submitted for a grant for 4 electronic speed signs with the Traffic Safety Committee and should hear if it is approved by the end of the month.

Police Department Commanders are researching additional grants, but the Police Department is prepared to purchase 2 signs if the grants are not approved.

## **On-Going or Future Topics, Discussions & Information**

- **Emergency Operations Center** – Continue working with the City, Fire Department, and King County Emergency Management on disaster preparedness issues facing the City in 2018. Chief Huebler presented a list of what King County Emergency Management provides the City of Enumclaw.
- **PSERN** – Puget Sound Emergency Radio Network – on-going 2019/20 project from King Co to replace PD mobile, officer, and dispatch radios.
