- A. Storywalk Presentation by KCLS/Library Advisory Board (Steven Bailey/Gretchen Nelson)
  - a. Finding a creative way to use library fundings with the COVID restrictions in place.
  - b. Storywalk would be outdoor displays of childrens books that are spaced out in approximately 20 story boards.
  - c. Park Board supports the idea of Storywalk; MacFarland Park was brought up as a good destination for the first Storywalk

O'Kelly made a motion to recommend to City Councill to approve the use of the Lafromboise endowment funds for the Storywalk in one of the City parks, Thode seconded, all in favor, recommendation passed.

  - b. Skate Park grant was not received; speaking with CSC for more guidance on what to do with this park.

- d. Discuss if we should put a restroom at MacFarland park with a splash padi. Looking into moving restroom from future "Pavilion Park" to MacFarland
- e. Park Board to bring any other recommendations for the Six year plan to the next meeting.
